

Procedures for Handling Players Report Cards

2010-2011



- 1) Players are responsible for providing their team manager with a copy (faxed, scanned and e-mailed or hard copy) of their report card to their team manager within 4 days of when report cards are mailed home (see date on Eligibility Calendar).
- 2) Each player must have a 70 or higher in ALL non-exempt classes to remain eligible to play in games. Classes that do NOT count against eligibility: AP, Honors & Pre-Cal. Any player who has a grade below 70 in a non-exempt class will be expected to participate in all team functions except they will not be permitted to play in games. A non-eligible player is ineligible for at least 3 weeks before it is possible to regain eligibility.
- 3) A grade of “Incomplete” in a non-exempt class is considered as a below 70 grade and the player is ineligible to play in games. However, the player can regain eligibility immediately upon turning in a report card which reflects the Incomplete to have been replaced with a grade of 70 or higher.
- 4) Any player not turning in a report card **BY THE DATE SPECIFIED** is considered ineligible and will miss at least one game until the appropriate report card is turned in to the Team Manager.
- 5) Non-exempt classes are listed on the PISD website.
- 6) The Team Manager will review the report cards and complete the AT&T High School Hockey League Eligibility List. The Team Manager will arrange to have the report cards verified by the appointed board member. The appointed board member will fax their lists to the League office.
- 7) All players who were ineligible to play due to grades must provide the Team Manager with a copy of their 3-weeks Progress Report for ALL classes. The player must have a grade of 70 or higher in ALL non-exempt classes to regain eligibility after serving the 3 week ineligibility, not just the class(es) that were under 70 on the report card.
- 8) Any player not regaining eligibility with the 3-week Progress Report remains ineligible until the next 6-weeks Report Cards are issued. If the player has a 70 or higher in all non-exempt classes, they regain eligibility immediately.
- 9) All copies of the report cards and all Progress Reports for each 6-weeks are to remain with the Team Manager until 30 days after the State Championship games and then are to be shredded. The grades are not be discussed with anyone except the Board and Team Coaches.

If ALL Progress Reports do not reflect passing, then player remains ineligible until next report card is reviewed.

End of 3rd 6-weeks: 12/17/10
Report Cards Mailed: 12/20/10
Report Cards Due to Team Managers by noon: 01/05/11

****Due to breaks of a week or longer, all students eligible during Winter Break 12/20/10-1/4/11**

3 Weeks Ineligible Dates: 1/11/11-2/1/11

3-week Progress Reports available: 1/25/11

Re-instatement date if ALL Progress Reports acceptable: 2/1/11

If ALL Progress Reports do not reflect passing, then player remains ineligible until next report card is reviewed.

End of 4th 6-weeks: 2/17/11
Report Cards Mailed: 2/24/11
Report Cards Due to Team Managers by noon: 03/1/11

****Due to breaks of a week or longer, all students eligible during Spring Break 3/11/11-3/20/11**

3 Weeks Ineligible Dates: 3/1/11-3/29/11

3-week Progress Reports available: 3/10/11

Re-instatement date if ALL Progress Reports acceptable: 3/30/11

If ALL Progress Reports do not reflect passing, then player remains ineligible until next report card is reviewed.

End of 5th 6-weeks: 4/14/11
Report Cards Mailed: 4/21/11
Report Cards Due to Team Managers by noon: 4/27/11

3 Weeks Ineligible Dates: 4/27/11-5/11/11

3-week Progress Reports available: 5/5/11

Re-instatement date if ALL Progress Reports acceptable: 5/12/11

If ALL Progress Reports do not reflect passing, then player remains ineligible until next report card is reviewed.
